Heart of America Buckskin Horse Association will be hereafter referred to as HABHA

1. HABHA reserves the right to refuse any vendor not in the best interest of the association.
2. The HABHA association shall have full power to interpret the commercial vendor regulations. Matters not covered by this contract shall be subject to a final decision by the HABHA Officers and Board of Directors.
3. The vendor assumes sole responsibility to protect, defend and secure their property and holds harmless the HABHA association, its employees, representatives, guests, volunteers, and exhibitors, the Lucky J Arena, its employees, representatives guests and agents from any wrong doing.
4. Vendor Acknowledges that the HABHA association and the Lucky J Arena do not maintain insurance covering vendor's property and the Vendor has the sole responsibility to obtain business interruption and property damage or theft insurance covering such losses by the vendor.
5. the Vendor may not occupy assigned spaces until all fees are paid in full.
6. HABHA reserves the right to restrict the vendor's exhibit, which because of noise, method of operation, materials or any other reason becomes objectionable.
7. If the Vendor is excused from the facility for violating any HABHA rules or an laws of the city of Carthage, no fees shall be returned.
8. The Vendor is responsible for setting up and tearing down all units he/she sets up at the show.
9. All Vendors are responsible for collecting and disposing of their own trash.
10. The Vendor will provide his/her own workers and equipemtn including extension cords and extra lighting to operate his/.her own booth.
11. The Vendor is responsible for collecting, reporting and submitting all required slaes tax on items sold at the show.
